**SENIOR TOURNAMENT RULES**  
**PLEASE READ CAREFULLY**

1. **ELIGIBILITY:**
  - a. Must be at least 50 years of age as of date of participation.
  - b. Must be a current member of the Illinois men's or women's bowling associations. Bowlers will be required to show their current USBC card or a receipt from current season.
  - c. Other bowlers from Illinois who are not current USBC members may enter by purchasing an associate membership card at the current USBC cost.
  
2. **COMPETITION WILL BE IN FIVE CLASSES:** CLASS E 50-54; CLASS D 55-59; CLASS C 60-64; CLASS B 65-69; AND CLASS A 70 and over. Doubles will be classified at the age of the younger partner. Male members will compete against male members only and women members will compete against women members only. It is the bowler's responsibility to verify their classification prior to bowling.
  
3. **EACH CLASS** of men/women All Event Champions will be eligible to compete at the National Senior Tournament. A "Super Senior" Champion (75 and over – men/women) will be eligible to compete at the National Senior Tournament also. The highest bowler in both 70-74 categories will be eligible to compete in the A Divisions at the National Senior Tournament.
  
4. **BOWLERS WILL USE THEIR HIGHEST USBC CERTIFIED AVERAGE** (verified on bowl.com) for the 2016-2017 season of 21 games or more. If no 2016-17 certified average, they will use their highest current USBC certified average as of October 28, 2017 based on 15 games or more. A copy of the bowler's current average sheet must be submitted as verification. If no certified current winter league average, a bowler may use a certified 2017 summer league average based on 21 games or more. If a bowler has none of the above, an assigned average for male bowlers shall be 200; female bowlers shall be 180.
  
5. **HANDICAP** will be 90% of the difference between the bowler's average and 220. Failure to use the proper average shall disqualify the score if the submitted average is lower than the actual average. If it is higher, prize winnings will be based on the submitted average.
  
6. **RE-RATING.** Bowlers who are subject to re-rating under the provisions of USBC Rule 319c will be required to follow the procedures for those rules.
  
7. **INCREASE RULES:** USBC Rule 319a-2 (10 pin increase provisions) will be waived.
  
8. **AVERAGE CORRECTIONS** can be made up to the end of the first game of a series; or, if an extension of time has been granted **IN WRITING** by tournament management before the end of the first game of the series, the correction can be made within 48 hours after the end of the series.

9. **A BOWLER IS PERMITTED** to bowl up to 4 times within the doubles division with a change of partners/gender and a change of class. Bowler may only bowl singles one time.
10. **ENTRANTS WILL BOWL DOUBLES FIRST** when bowling back to back squads. Doubles will be on one pair of lanes and singles will be on another set of lanes. No doubles partners will be furnished. Rearranging of partners **WILL NOT BE PERMITTED**. No more than six (6) bowlers will be assigned to a pair of lanes. Doubles and singles need not be bowled in successive squads or in the same day.
11. **ALL PRIZE FEES** returned 100% in cash prizes for both men and women. Prize ratio to be at least: Doubles – 1 for every 8 entries; Singles – 1 for every 8 entries; All Events – 1 for every 12 entries; Mixed Doubles – 1 for every 4 entries.
12. **FIRST PLACE TIES:** In the event of first place ties, the most pins over average (scratch score) determine winners. **ALL EVENTS PARTICIPANTS ONLY:** Should a first place tie occur, most pins over average (scratch) determines national winner. **FIRST APPEARANCE IN A DOUBLES EVENT WILL APPLY TOWARD THE ALL EVENTS.**
13. **BOWLERS WILL NOT** be required to report previous winnings of \$600.00 or more.
14. **A BOWLER WHO MISSES** one or more frames by not being present and ready to bowl when it is their turn shall not be credited with any pins for frames missed.
15. **PRIZE LIST:** Prize lists will be furnished upon written request. **WINNERS WILL RECEIVE A PRIZE LIST IN THEIR WINNING CATEGORY ONLY.**
16. Walk-ins must provide State ID and average verification one hour prior to squad time. (Subject to lane availability) Re-entries: Must notify tournament manager one hour prior to squad time. (Subject to lane availability)
16. **ANY** other problems that may arise will be referred to the tournament manager.
